



Prof Ishenkumba Kahwa is the new head of the Jamaica Country Nominating Committee. He is Professor Emeritus at the UWI, Mona, where he served for 31 years till his retirement in 2018.

He joined the Department of Chemistry, University of the West Indies, Mona in 1987. He served as Professor of Supramolecular Chemistry from 2000, Head of the Department of Chemistry (2002-2008), and Dean of the Faculty of Science and Technology for the period 2008-2013.

As Deputy Principal at the Mona Campus (2013-2018), Prof Kahwa led the development and establishment of a new suite of BSc, MSc, MPhil and PhD programmes in Occupational and Environmental Safety and Health (OESH).

Prof Surujpal Teelucksingh has assumed the chairmanship of the Trinidad and Tobago Country Nominating Committee.

Prof Teelucksingh is the Science & Technology Laureate for 2011. He is a medical doctor, researcher and lecturer at the University of the West Indies, Mt Hope, medical school.

Among his many interests is diabetes research and he is director of the DERPI (Diabetes Education Research Institute) which he founded in 2007. He has been recognised by UWI as an outstanding researcher (2015) for his work in the regional collection and analysis of medical data on chronic non-communicable diseases.





Dr Angela Alleyne is the new chair of the Barbados Nominating Committee. She is a biologist and biochemist from the University of the West Indies, Cave Hill. She specialises in plant pathology throughout the region and population genetics of fibroids among AfroCaribbean women in Barbados.

Her professional society memberships include the British Society of Plant Pathology, the Biochemical Society of the UK, the (UK) Royal Society of Biology, the American Society for Microbiology, and the American Phytopathology Society.

She has also attracted research funding from the Canada Latin America and the Caribbean Research Exchange grant programme, the American Phytopathology Association, the (US) Environmental Protection Agency, and the J Craig Venter Institute.


Prof Brereton is a former professor of history, and the book is a series of small snapshot studies of popular history of interest to the lay reader.


Topics broached include festivals, historical events, the various historical narratives that compete vigorously in the public sphere in Trinidad and Tobago.
